Fax entries that are received incomplete or illegible will not be accepted. Proof of transmission does not verify receipt of a faxed entry. Telephone entries are not accepted.

Checks made payable to any club or to anyone other than Pam Moore will incur a \$10.00 fee per incorrect check. This fee must be paid before the entry can be accepted.

- Fax entries are accepted at 989-723-8939. Payment may be made by PayPal or credit card. If paying by credit card, include card number, expiration date, security code (CVV) and billing zip code.
- Email entries may be submitted with PayPal payment to sheltiepam@earthlink.net.
- A \$2.00 processing fee per dog, per show, applies to all PayPal and credit card payments.

Emailed entries must include a clear, legible copy of the complete signed entry form, submitted as either a scanned document or a high-quality photograph.

Returned checks and declined credit cards do not constitute valid payment. Any returned check or declined credit card must be made good before the dog is permitted to compete.

A \$25.00 service fee will be assessed for each returned check or declined credit card, in addition to the original entry fees. Payment must then be made by cash, money order or cashier's check.

Exhibitors with repeated returned checks or declined credit cards may be required to pay by cash only for future entries.

FOREIGN EXHIBITORS

Entries must be accompanied by checks drawn on a U.S. bank, international money orders in U.S. funds or electronic payment in U.S. funds, as approved by the show secretary.

BCA assumes no responsibility for protection of personal information, including credit card information, that is sent by email to the event secretary.

CONDITIONAL, UNSIGNED, INCOMPLETE OR ENTRIES RECEIVED WITHOUT CORRECT FEE AMOUNTS WILL NOT BE ACCEPTED.

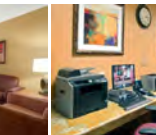
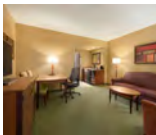

Participants will also have the opportunity to discuss breed-specific characteristics, common misconceptions and practical judging considerations.

All dogs entered in the Bred-By Exhibitor class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

(3 POINTS FOR RESERVE WINNERS OFFERED FOR ALL SHOWS)

Chapter 16, Section 1: Unless the breed club, in its application to hold a specialty show, chooses to exclude, the following award shall be offered. At a specialty show the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners.

NON-REGULAR CLASSES

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

VETERAN DOGS

For dogs and bitches **7 (Seven)** years of age and older. Open to Champions and non-Champions alike. A dog may be entered in the Veterans Class without being entered in any other class. Dogs & Bitches will be judged separately. First place winners of the Veteran Dog Class and the

Veteran Bitch class are eligible to compete in the Best of Breed competition if otherwise undefeated at this specialty show.

"Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch class.

AWARD OF MERIT

At the Judge's discretion, no more than 5 deserving dogs or bitches, in the ring for Best of Breed, may receive an Award of Merit.

It is not mandatory that the judge award any certificates. Dogs

awarded Best of Breed, Best of Opposite Sex to Best of Breed and Best of Winners are excluded from selection by virtue of their higher placement. The Award of Merit shall be given following Best of Breed, Best of Winners, Best of Opposite, Select Dog and Select Bitch. (Not offered at the BCA Division II show)

BEST PUPPY COMPETITION (from the classes)

From the first-place winners in each sex of the Puppy classes

BEST BRED-BY EXHIBITOR (from the classes)

From the first-place winners in each sex of the Bred-by Exhibitor classes

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in these classes is based on the merits of more than one dog, none of the dogs judged first in the class will be eligible for Best of Breed Competition by virtue of having won this class.

**STUD DOG (OFFERED AT THE NATIONAL AND WESTERN MICHIGAN SHOWS)

Stud Dogs shall consist of 2 get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. While the merits of the stud dog are not to be considered in placement of the entry, the stud dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed. Get must be entered individually in a regular class. Best of Breed or some other non-regular class of the same show. Get only to be judged. (Neutered Stud Dogs may be entered).

**BROOD BITCH (OFFERED AT THE NATIONAL AND WESTERN MICHIGAN SHOWS)

Same as for the Stud Dog except substitute Brood Bitch for Stud Dog. (Spayed Brood Bitches may be entered).

"Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a castrated male may be entered as a Stud Dog

in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class.

BRACE (OFFERED AT THE NATIONAL SHOW ONLY)

For two dogs of the same recognized breed that are similar in appearance, performing in unison and presented by a maximum of two handlers. Both dogs competing in Brace competition must have at least one common owner. The dogs comprising the brace MUST BE named at the same time of the entry. If a dog which is to be part of Brace is not entered in another class, it must be entered as "Brace Class Only." In making entries for "Brace Class Only" full particulars must be given for each dog on an individual regular entry form. An entry form for a dog entered in another class and entered as a part of a brace MUST BE marked accordingly in the space provided for Additional Classes, "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace unit must be so designated "Brace No. 1", "Brace No. 2" etc. **Please submit brace entries together.**

To be eligible for Beginner Novice A, a handler must own the dog entered or be a member of the owner's household or immediate family and may not have previously handled any dog that has earned any AKC Obedience title. Owners may enter more than one dog in this class. No dog may be entered in both Beginner Novice A and Beginner Novice B at any trial.

BEGINNER NOVICE B

The owner or any other person may handle dogs in this class to earn a BN title. Owners may enter more than one dog in this class. No dog may be entered in both Beginner Novice A and Beginner Novice B at any trial.

AKC NATIONAL OWNER-HANDLED SERIES

(REMEMBER TO CHECK THE BOX NEAR THE BOTTOM OF THE ENTRY FORM)

The AKC National Owner-Handled series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by "professional handlers meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book and the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and **Current assistants to professional handlers may not exhibit the dog in any competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed is eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog and Select Bitch are both eligible, the judge is to choose Owner-Handled Best of Breed from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and Non-Regular class winners of the same sex and then choose Owner-Handled Best of Breed from the remaining dogs of the opposite sex including the eligible winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed.
- If the Best of Winners is eligible, the other winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog and Winners Bitch are eligible to return to the ring.

***PROFESSIONAL HANDLERS** are defined as any person who belongs to, or has belonged to, a professional handlers organization, has distributed rate cards, or has otherwise advertised or represented themselves as handling dogs for pay within the past five years.

A current **ASSISTANT is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any show during the cluster/weekend.

JUNIOR SHOWMANSHIP

NOVICE JUNIOR

For youth at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards*, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE

For youth at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards*, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR

For youth at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards*, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR

For youth at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards* in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE

For youth at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards* in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR

For youth at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards* in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER

For youth at least 9 and under 18 years of age on the day of the show who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

**A first place in Novice without competition leading to a Best Junior Handler award with competition counts as one win toward moving to Open.*

Be sure all information for junior showmanship classes is entered on the front and back of the entry form.

An additional entry in a corresponding specialty class is not required to enter junior showmanship only. Dogs may be substituted for junior showmanship. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one-half hour prior to the judging of any junior showmanship classes at the show. Every dog entered for junior showmanship must be eligible to compete in conformation dog shows or in obedience trials.

BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a breed judge or by a bench show committee may still be handled in junior showmanship if eligible to compete in obedience trials. A dog that has been rejected, dismissed or excused by a veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in junior showmanship. Junior handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the superintendent at least one-half hour prior to the scheduled start of any regular conformation judging or one-half hour prior to the scheduled start of junior showmanship judging at the show, whichever is earlier. Winning first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited junior showmanship classes.

For information on eligibility requirements for limited junior showmanship classes approved by the AKC, visit akc.org. Junior handlers must include their AKC Junior Handler identification number on the entry form. To obtain a junior identification number, contact juniors@akc.org or call the AKC at 919-233-9767.

PEE WEE HANDLER

The Pee Wee Special Attraction is a pre-Junior Showmanship class for children ages 5-9. Each Pee Wee unit consists of the child, a parent, guardian or responsible adult, and the dog. Only one Pee Wee unit is permitted in the ring at a time. This is not a competitive class but rather a fun, educational experience for the child and the accompanying adult.

Dogs must be at least 4 months old to enter the Pee Wee class. Only bulldogs are eligible for this event. Dogs do not need to be AKC-registered to participate and do not need to be entered in the specialty. Bitches in season will not be permitted to participate. If pre-entered, a dog may be substituted.

All dogs entered must wear an appropriate collar and lead. A responsible adult must be present with the child both inside and outside the ring. Outside the ring, the dog must be controlled by the accompanying adult. An additional lead, provided by the club, will be available at the judge's table. At the judge's discretion, based on the size of the child and the dog, the adult may be asked to attach a second lead so both the child and the adult can walk the dog together.

Entry forms and the Pee Wee Release of Liability will be available at the show. The release must be signed by the child's parent or legal guardian.

CGC & TRICK DOG TESTS



CGC CANINE GOOD CITIZEN

The Canine Good Citizen (CGC) test is the foundation level of the AKC's family dog programs. It evaluates 10 basic manners and obedience skills in a controlled, simulated environment, such as a training ring.

What it tests:

Accepting a friendly stranger, sitting politely for petting, appearance and grooming, walking on a loose leash, walking through a crowd, sitting and lying down on command, staying in place, coming when called, reacting appropriately to another dog and reacting appropriately to distractions.

Dogs must wear a regular collar or harness. Pinch collars are not permitted.



CGCA AKC COMMUNITY CANINE

This is the advanced level. It requires the dog to already have a base-level CGC on record.

What it tests:

The same skills as the foundation CGC, but in real-world settings with heavy distractions (like at a real dog show or a busy park).

Key tasks:

It tests if your dog can walk through a crowd while you are wearing a backpack, wait on a sit/stay while you step away, and walk politely on a leash past other dogs.



CGCU AKC URBAN CGC

This level requires the dog to pass a Public Access Test in a real city environment.

What it tests:

City-specific reliability.

Key tasks:

Walking through a busy city block, navigating stairs or elevators, walking past buildings and open doors, and being well-behaved while you sit at an outdoor restaurant or wait in a store.



TKN NOVICE TRICK DOG

Requires 10 tricks from the AKC Novice Trick Dog checklist. Handlers may use food or toy lures to guide their dog into position. Dogs with an AKC Canine Good Citizen (CGC) title or certificate on record receive credit for five tricks and need to perform only five additional novice tricks.

TKI INTERMEDIATE TRICK DOG

Requires 10 intermediate tricks. At this level, food/toy lures must be faded out, though food rewards are still allowed after the trick is finished.

TKA ADVANCED TRICK DOG

Requires 10 advanced tricks from the AKC Advanced Checklist. Lures are entirely forbidden, the dog must work strictly from verbal or physical cues.

TKP TRICK DOG PERFORMER

Requires a short, 10-trick routine. At least 3 of these tricks must be at the Performer level, and at least 3 must utilize props to assist in telling a short story. No standard obedience or agility equipment may be used. Trick Dog Elite Performer (TKE): The highest tier requires a cohesive 10-trick routine with an explicit story or script. It must utilize at least 5 props, and at least 5 tricks must be from the Performer category.

AKC TEMPERAMENT TESTS



TWO TESTS OFFERED, BULLDOGS ONLY, ONE YEAR OF AGE AND UP, LIMITED TO 10 DOGS

The AKC Temperament Test (ATT) is a general temperament test that will assess the dog's reaction to a variety of stimuli. These stimuli will be in the following six categories: Social, Auditory, Visual, Tactile (touch), Proprioceptive (motion) and Unexpected Stimuli.

This event is a pass/fail test. It is not a competition and there is no pre-qualifying.

ELIGIBILITY TO ENTER

Dogs who are at least 1 year of age are eligible to take the ATT and must either be AKC or FSS registered, listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate. Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. Dogs with disabilities such as those that are blind, deaf or have three legs are eligible to enter provided, in the opinion of the evaluator, they display no signs of physical discomfort and can safely complete the test. If a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title. Bitches in season are eligible to participate but will be placed as the last dog(s) to be tested.

TEST INFO

The ATT is a noncompetitive pass-fail test. In a test, a dog must pass 3 test items in each of the six categories (total of 18 test items). These are selected from a list of 24 possible test items.

COLLARS, LEASHES

Dogs may wear slip collars that are on the dead ring, buckle collars, martingales and body harnesses in the ATT. They may not wear prong collars, head collars, e-collars or harnesses that restrict the movement of the dog. Leashes shall be 4ft. to 6ft. long and made of fabric or leather.

DOGS THAT PASS – CAN APPLY FOR A TITLE

Owners or handlers of dogs that pass both tests may complete the AKC Temperament Test (ATT) Title Application and give to the Event Chair, Amy Cunningham. Titles will be recorded and sent to the owner of record. The AKC Temperament Test (ATT) title processing fee is \$32.00.

BULLDOG *of the* YEAR



1. PURPOSE

This event was created to showcase bulldogs that have made the greatest contribution in the ring to breed recognition during the previous calendar year.

2. SUMMARY OF EVENT RULES

The event is intended to be formal.

All committee members and directors are eligible to participate.

Invitations will be sent by August 12, 2026 prior to the National Specialty at which this event will be held.

All RSVPs must be returned to the Event Director by September 2, 2026. Late entries will not be accepted and will be returned.

3. ELIGIBILITY AND ENTRY REQUIREMENTS

Participation is by invitation only.

To receive an invitation, a dog or bitch must have achieved at least one of the following during the previous calendar year:

Ranked among the
Top 20 bulldogs in breed points
the previous year (2025) or

Won a bulldog specialty show within
July 1, 2025 – July 1, 2026 or

Won Best of Breed at the
Westminster Kennel Club Show 2026 or
the AKC National Championship 2025.

Won an all-breed Best in Show between
July 1, 2025 – July 1, 2026.

The entry fee for this event is \$100.00, which is non-refundable.

4. JUDGING QUALIFICATIONS

Category No. 1 – MULTI-BREED JUDGE

Must be licensed by the AKC, FCI or KC to judge bulldogs and at least one other breed.

If no multi-breed judge is present, a breeder judge may be selected from the breeder judge ballot box.

Category No. 2 – BREEDER JUDGE

Must be AKC, FCI or KC licensed to judge bulldogs.

Category No. 3 – BREEDER

Must have a minimum of 10 years of documented experience breeding bulldogs.

Category No. 4 – PROFESSIONAL HANDLER

Must be a professional handler who charges a fee for services and has experience handling multiple breeds, including bulldogs.

If no professional handlers are present, a breeder may substitute in this category.

Judge Selection Process: The names of eligible judges will be placed into individual ballot boxes by category. At the start of the event, the current BCA President will draw one name from each box to determine the judging panel. All individuals who wish to be considered should dress in appropriate formal attire in case they are selected. Dogs owned by the event's judges may not participate in this event but may enter other regular or non-regular BCA classes. Once a person has judged the Bulldog of the Year event, they are ineligible to judge again for a period of three years.

5. SEQUENCE OF JUDGING

Each participant will be judged by four judges. Each judge will award up to 100 points, according to the AKC breed standard, for a possible total of 400 points per participant.

Each dog will be evaluated by four judges in approximately five minutes.

Two committee members who are not exhibitors will serve as official scorekeepers.

Scorecards will be collected immediately after each dog is judged.

The dog or bitch receiving the highest total score (closest to 400) will be awarded the title 'Bulldog of the Year.'

In the event of a tie, the tied dogs will return to the ring for a tiebreaker round. All four judges will then select the winner by ¾ majority vote.

Second runner-up and First runner-up will also receive a rosette.

6. TROPHIES AND AWARDS

The winner will receive a commemorative rosette and ribbon, with colors to be determined by the event committee.

All qualified participants will receive a commemorative award.

The breeder of the winning dog will receive a commemorative ribbon equivalent to that of the owner's award.

It is the responsibility of each owner to pick up all prizes or make prior arrangements. No awards will be shipped.

7. DISTRIBUTION OF EVENT FUNDS

50% of the total entry fees will be awarded to the Bulldog of the Year: 70% to the owner(s) and 30% to the breeder. One party must be a BCA member. If one party is not a member, that portion of the funds will be retained by the division.

50% of entry fees will be go the division to help fund the current national specialty.

8. PEOPLE'S CHOICE

BCA members in good standing are eligible to receive a ballot and vote for their favorite dog of the evening. Membership will be verified and only those on the current roster will be issued ballots.

NOTICE TO EXHIBITORS

GENERAL INFORMATION

Bulldogs are to be judged on a ramp.

No dogs are permitted in the show area except those officially entered. Puppies younger than 6 months are not permitted at the show hotel. No dogs or puppies may be sold on the show grounds.

The hosting clubs reserve the right to postpone, cancel or modify any event because of severe weather, natural disaster, public emergency, civil disturbance or other circumstances beyond their control.

ENTRIES

Entries must be submitted on an official AKC entry form or exact copy and signed by the owner or the owner's authorized agent. Owners are responsible for the accuracy of all information submitted. Conditional entries will not be accepted.

Entry fees must be paid in U.S. funds by an approved method. Returned checks or declined payments must be made good before dogs will be allowed to compete and are subject to applicable service charges.

Entry fees will not be refunded for absent dogs, disqualifications, veterinarian or judge excusals, errors in entry or events canceled because of circumstances beyond the control of the hosting clubs.

An AKC Event Service Fee will be collected where applicable in accordance with current AKC Rules and Regulations.

JUDGING

Judging programs will be distributed according to the event secretary's published procedures.

Dogs may arrive at any time before their scheduled judging. Dogs not required for further competition will be excused.

Owners and handlers are responsible for having their dogs ready when called. Judges are not required to wait for late exhibitors.

Dogs completing championship requirements after entries close may be transferred to Best of Breed competition in accordance with current AKC rules.

SHOW GROUNDS

Dogs must be on leash or securely confined except while being judged. Crates, ex-pens and grooming tables are not permitted within 10 feet of any ring.

Do not leave dogs unattended in closed vehicles.

Cell phones and other electronic devices must be silenced while judging is in progress.

Care for show site facility is of utmost importance to the BCA. Whenever it is determined that an exhibitor has caused personal property damage to the hotel or has impaired the club's ability to retain a show site, the Event Committee shall convene to conduct a preliminary investigation in accordance with AKC publication "Dealing With Misconduct." If the investigation finds the exhibitor's conduct to be prejudicial to the sport, an event hearing will be conducted. If charges are upheld, restitution must be made immediately to said hotel by the violator(s), and the following actions may also be taken:

- The person, or persons, found in violation of the hotel/motel policies and/or AKC/BCA rules shall be asked to leave the premises immediately.
- The violating exhibitor shall be subject to additional penalties from BCA and AKC, up to and including suspension. As appropriate, the offending name(s) shall be published in the AKC Gazette and The Bulldogger as having been found guilty of violating cited AKC/BCA rules.

Failure to immediately clean up after any dog in your care anywhere on the show grounds, including inside or outside the building, parking areas and show rings, will result in the following fines:

**First offense: \$50
Second offense: \$200
Third offense: Removal from the show grounds without refund.**

Additional disciplinary action may be taken by the Event Committee.

Smoking is prohibited except in designated areas. Dogs must be crated while in hotel rooms. Bathrooms may not be used as dog housing. Guest rooms may be inspected by hotel staff or the Event Committee.

HEALTH & SAFETY

Exhibitors are responsible for the health, safety and welfare of their dogs. Dogs exhibiting signs of contagious illness or aggressive behavior may be excused or removed from the show grounds.

Exhibitors are responsible for complying with all applicable federal, state and local animal health regulations, including current USDA requirements and any New World

screwworm restrictions in effect at the time of the event.

Emergency veterinary information is provided on page 4 of this premium list.

AWARDS
